KEY OPERATING DATA OF 2024 THIRD QUARTER

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) hereby announces the key operating data of 2024 third quarter of the Company and its subsidiaries (collectively, the “**Group**”).

NEW ENERGY BUSINESS SEGMENT

According to the Company’s preliminary statistics, the power generation of the Group on a consolidated basis for the 2024 third quarter amounted to 2,305,457.14 MWh, representing a decrease of 2.29% over the corresponding period of 2023; the on-grid power generation amounted to 2,241,608.49 MWh, representing a decrease of 2.53% over the corresponding period of 2023. As of 30 September 2024, the accumulated power generation amounted to 9,836,370.79 MWh, representing a decrease of 3.31% over the corresponding period of 2023; the accumulated on-grid power generation amounted to 9,597,191.69 MWh, representing a decrease of 3.45% over the corresponding period of 2023. From January to September 2024, the average on-grid tariff (tax exclusive) of the Group was RMB0.44/KWh, flat as that for the same period last year; the Group’s transacted electricity volume in the electricity market amounted to 3,571,759.09 MWh, the proportion of transacted electricity volume in the electricity market amounted to 37.22%, representing a decrease of 2.42 percentage points over the corresponding period of 2023.

GAS BUSINESS SEGMENT

According to the Company's preliminary statistics, the transmission/sales volume of gas of the Group on a consolidated basis for the 2024 third quarter amounted to 1,115.1729 million cubic meters, representing an increase of 23.41% over the corresponding period of 2023, of which, the sales volume of gas amounted to 934.6745 million cubic meters, representing an increase of 21.41% over the corresponding period of 2023; the volume of gas transported by the Group for its clients amounted to 180.4985 million cubic meters, representing an increase of 34.89% over the corresponding period of 2023. As of 30 September 2024, the accumulated transmission/sales volume of gas amounted to 4,508.5994 million cubic meters, representing an increase of 37.09% over the corresponding period of 2023, of which, sales volume of gas amounted to 3,951.6813 million cubic meters, representing an increase of 39.67% over the corresponding period of 2023, the volume of gas transported by the Group for its clients amounted to 556.9181 million cubic meters, representing an increase of 21.20% over the corresponding period of 2023.
