**KEY OPERATING DATA OF 2021 THIRD QUARTER**

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) hereby announces the key operating data of 2021 third quarter of the Company and its subsidiaries (collectively, the “**Group**”).

**NEW ENERGY BUSINESS SEGMENT**

According to the Company’s preliminary statistics, the power generation of the Group on a consolidated basis for the 2021 third quarter amounted to 1,928,569.91 MWh, representing an increase of 17.46% over the corresponding period of 2020; the on-grid power generation amounted to 1,817,019.94 MWh, representing an increase of 22.68% over the corresponding period of 2020. As of 30 September 2021, the accumulated power generation amounted to 9,565,541.94 MWh, representing an increase of 42.24% over the corresponding period of 2020; the accumulated on-grid power generation amounted to 8,841,430.59 MWh, representing an increase of 41.01% over the corresponding period of 2020. From January to September 2021, the average on-grid tariff (tax exclusive) of the Company was RMB0.48/KWh, representing an increase of 1.55% over the corresponding period of 2020; the Company’s transacted electricity volume in the electricity market amounted to 893,303.00 MWh, the proportion of transacted electricity volume in the electricity market amounted to 10.10%, representing a decrease of 4.82 percentage points over the corresponding period of 2020.

As of 30 September 2021, the accumulated sales volume of gas amounted to 2,715,827,100 cubic meters, representing an increase of 13.42% over the corresponding period of 2020.
